### Standard & Poor's to Include St Barbara Ltd in the S&P/ASX 200

SYDNEY, Feb. 21, 2008—Standard & Poor's Index Services Australia today announced that it will remove Symbion Health Ltd (ASX: SYB) from the S&P/ASX indices, after Primary Health Care Ltd. (ASX: PRY) acquired in excess of 70% of shareholder acceptances, and declared its offer unconditional. Symbion Health Ltd will be removed from the S&P/ASX indices after the close of business on Feb. 28, 2008.

Symbion Health Ltd. will be replaced by Bank of Queensland Ltd. (ASX: BOQ) in the S&P/ASX 100 and by St Barbara Ltd. (ASX: SBM) in the S&P/ASX 200. Felix Resources Ltd. (ASX: FLX) will replace Symbion Health Ltd. in the S&P/ASX All Australian 200. These changes are scheduled to become effective after the close of business on Feb. 28, 2008.
